#### Mandate

The Presbyterian Committee on the Self Development of People (SDOP) shall assist the Presbyterian Church (U.S.A.) in carrying out its global commitment to work toward the self development of economically poor, oppressed, and disadvantaged people, who own, control, and benefit directly from projects that promote long-term change in their lives and communities. The mandate was established by the 182nd General Assembly of the former United Presbyterian Church, U.S.A. in 1970, and reaffirmed and approved by the 199th General Assembly (1987) of the Presbyterian Church (U.S.A.).

## Mission

Self-Development of People is a ministry that affirms God's concern for humankind. We are Presbyterians and ecumenical partners, dissatisfied with poverty and oppression, united in faith and action through sharing, confronting and enabling. We participate in the empowerment of economically poor, oppressed and disadvantaged people who are seeking to change the structures that perpetuate poverty, oppression and injustice.

#### **National Committee**

The National Committee is composed of thirty-one (16) persons, chosen to reflect diversity and inclusiveness. At least 75 percent of the members shall be members of the Presbyterian Church (USA); a majority of the members (51 percent) will be racial/ethnic persons.

# Membership

The membership shall be composed of eleven (11) at large members, nominated by the General Assembly Nominating Committee; two (2) member nominated by Synods; and three (3) members nominated by Presbyteries, in consultation with the General Assembly Nominating Committee, to facilitate meeting the competency and needs of the National Committee.

# **Key Duties & Responsibilities**

- Promote and interpret the SDOP ministry and promote the One Great Hour of Sharing Offering, including all three of its ministries— Self-Development of People, Presbyterian Hunger Program, and Presbyterian Disaster Assistance.
- Educate the Presbyterian Church (USA) on the condition and status of economically poor and oppressed communities, and share related theological insights.
- Determine mission and purpose, overall strategies, policies and priorities of the SDOP ministry.
- Seek-out, receive, and evaluate applications from groups of economically poor, oppressed, and disadvantaged people.
- Work to establish SDOP Committees in Presbyteries/Synods where they do not exist.
- Work cooperatively with ecumenical partners in the self-development effort and with the Compassion, Peace and Justice Ministry area to enable a coordinated approach to development.

## **Time Commitment**

The National Committee meets three times a year (January, May and September). Task Forces meet in conjunction with the National Committee and between each National meeting. Committees meet in conjunction with National Committee meetings. Each member is assigned to serve on a regional Task Force, and Standing Committee (Community and Church-wide Relations, Personnel) or the International Task Force. The International Task Force meeting schedule is similar to other Task Forces. Committee members are responsible for conducting site visits to potential partners in the United States, conducting training sessions for Synod/ Presbytery SDOP Committees and leading workshops for community groups. Currently meeting via zoom.
