Guidelines for Programmatic Emphases Inclusion in the Planning Calendar That Can Be Included in PC(USA) Printed Materials (Approved by the General Assembly Council, February, 1998)

The following criteria reflects the theological and liturgical grounding in which our programmatic emphases are rooted, as well as the need for practical materials to enable our members to observe approved emphases.

- 1. Display of the Programmatic emphases will be negotiated in order determined based on a commitment to honor the liturgical calendar, the lectionary, and the programmatic needs of the denomination.
- 2. The Easter cycle (Ash Wednesday through Pentecost), the Christmas cycle (First Sunday of Advent through Epiphany), The Season of Advent and Christmas (through Christmas Day), the Season of Lent and Easter Sunday, as well as the historic feasts of Epiphany, The Transfiguration, The Day of Pentecost, Trinity Sunday, and the Festival of Christ the King (Reign of Christ) will be kept free of programmatic emphases except for special Sundays designated by action of the General Assembly, the One Great Hour of Sharing Offering, the Pentecost Offering, and the Christmas Joy Offering.
- 3. Programmatic emphases may be included yearly provided an annual written request is made, will be determined annually. Each request for inclusion must be submitted in writing, along with a rationale for including the emphasis and the particular day that is requested. Appropriate program staff shall also provide annual written reminders of special emphases that should be included on the basis of previous General Assembly actions.
- 4. <u>A programmatic emphasis Programmatic emphases will be listed in the planning calendar included only if supporting resources are available.</u>
- 5. Year-with emphases and other churchwide themes approved by the General Assembly may take precedence over other requested items.
- 6. Each program team will normally have no more than one *programmatic* emphasis. and No more than one emphasis may be assigned to any given Lord's Day. Requested emphases will be reviewed for overlap and redundancy.
- 7. *Major* Orthodox, Jewish, and Islamic holidays will be included for information in the list of Special Days and Seasons on a separate part of the planning calendar.
- 8. Special offerings will be clearly identified.
- 9. <u>All suggested items for inclusion</u> The suggested list will be submitted to the Winter/Spring meeting of the Congregational Ministries Division Committee in the year prior to the suggested year of publication, for recommendation to the General Assembly Council.

THEOLOGY AND WORSHIP

CONGREGATIONAL MINISTRIES DIVISION

Sisters and Brothers in Christ,

May grace and peace be yours in abundance in the knowledge of our God and Savior Jesus Christ. We share with you our joy that almighty God, creator of heaven and earth, also created us; that this same God came to humankind in Jesus Christ to redeem us from sin and create us anew; and that God the Holy Spirit remains with us, leading us to faith and empowering us for new life.

Christians declare their common faith by bearing witness to God's grace in Jesus Christ, expressing their testimony in words and deeds as the time requires. In our time and place, the Presbyterian Church (U.S.A.) confesses its faith through eleven creeds, confessions, and catechisms in *The Book of Confessions*. The confessions of the church articulate the shared faith of the church:

In these confessional statements the church declares to its members and to the world

who and what it is,

what it believes,

what it resolves to do.

These statements identify the church as a community of people known by its convictions as well as by its actions. They guide the church in its study and interpretation of the Scriptures; they summarize the essence of Christian tradition; they direct the church in maintaining sound doctrines; they equip the church for its work of proclamation. [Book of Order, G-2.0100]

The comprehensive witness of *The Book of Confessions* is sufficient to lead, instruct, and guide the church. From time to time, however, questions arise in the church that call for careful articulation of a particular aspect of Christian faith, drawing upon the testimony of the confessions in a way that illuminates the unique and authoritative witness of the Scriptures. Such occasions do not require a new confession, but rather a faithful expression of the consistent teaching of Scripture and confessions. In this way, we may be helped to re-appropriate central affirmations of the faith and to renew our faithful witness in the world.

In recent times, some within the Presbyterian Church (U.S.A.) have expressed understandings of Jesus Christ that other Presbyterians believe breach the limits of Scripture and the church's confessions. Many Presbyterians have been dissatisfied with responses to the controversy, and some have questioned the clarity of the General Assembly's affirmation of Jesus Christ as Savior and Lord.

The 213th General Assembly (2001) requested the Office of Theology and Worship to help the church better understand the theological richness of the Lordship of Jesus Christ. The Office of Theology and Worship has prepared a concise articulation of the church's historic faith, which also expresses the clear convictions, of the Office of Theology and Worship. We invite all Presbyterians to join us in reaffirming the faith that has been imparted to us through the testimony of the great cloud of witnesses.

Peace be to the whole community, and love with faith.

HOPE IN THE LORD JESUS CHRIST

We declare to you what was from the beginning, what we have heard, what we have seen with our eyes, what we have looked at and touched with our hands, concerning the word of life – this life was revealed, and we have seen it and testify to it, and declare to you the eternal life that was with the Father and was revealed to us – we declare to you what we have seen and heard so that you also may have fellowship with us; and truly our fellowship is with the Father and with his Son Jesus Christ. We are writing these things so that our joy may be complete. [1 John 1:1-4]

"Jesus is Lord!" This foundational declaration is the earliest Christian confession of faith. The Scriptures and our confessions expand the basic affirmation, providing abundant witness to the word of life revealed in Jesus Christ. "The depth of the riches and wisdom and knowledge of God" revealed in Christ far exceed the scope of this brief exposition. We cannot say all there is to be said, but there is much that we can say, clearly and confidently.

Christian faith is Trinitarian faith. Our understanding of Jesus Christ is necessarily expressed within our understanding of "the one triune God, the Holy One of Israel, whom alone we worship and serve." From the Nicene Creed to A Brief Statement of Faith, the church shapes its confession by the certain knowledge of the grace of the Lord Jesus Christ, the love of God, and the communion of the Holy Spirit. Throughout the ages, when praying at the Lord's table and the baptismal font, Christians have given thankful praise for God's work in creation, providence, and covenant history – followed by thankful recalling of the acts of salvation in Jesus Christ – and concluding with a call for the abiding presence of the Holy Spirit. It is the faith expressed in creed and prayer that we invite all Presbyterians to speak and live.

In Jesus Christ, God was reconciling the world to himself. Jesus Christ is God with us. He is the eternal Son of the Father, who became human and lived among us to fulfill the work of reconciliation. He is present in the church by the power of the Holy Spirit to continue and complete his mission. This work of God, the Father, Son, and Holy Spirit, is the foundation of all confessional statements about God, humankind, and the world. [The Confession of 1967, 9.07]

WE BELIEVE IN ONE GOD [Nicene Creed, 1.1]

Our faith is in God who created heaven and earth, who formed us from dust and breathed us into life, who made us to live with one another in love. Our faith in God is far more than generalized belief in an abstract deity. We trust in God who loved us and sought us even when we chose sin and death rather than communion and life. We are loyal to God who established a covenant with us through Abraham and Sarah, who revealed the shape of faithful living in the Law given through Moses, and who called us to obedience through the cries of the prophets.

> Be joyful in the Lord, all you lands; serve the Lord with gladness and come before God's presence with a song. Know this: The Lord alone is God; we belong to the Lord, who made us. [Psalm 100:1-3]

God is known to us only through self-disclosure in words and acts of grace, love, and communion. While complete knowledge of God remains beyond human capacity, and human attempts to imagine the divine nature easily become reflections of our own desires or fears, God has revealed the truth to us in the One who is the Truth. God is most fully known to us through God's free presence with us in Jesus Christ.

> In the beginning was the Word, and the Word was with God, and the Word was God.... And the Word became flesh and lived among us, and we have seen his glory, glory as of the Father's only Son, full of grace and truth.... No one has ever seen God. It is God the only Son, who is close to the Father's heart, who has made him known. [John 1:1, 14, 18]

Thus we join with the church throughout the centuries to affirm that God was in Christ. God is not a mysterious unknown who remains veiled in remote transcendence. God has come among us in terms we can understand, in the human one, Jesus of Nazareth.

The one sufficient revelation of God is Jesus Christ, the Word of God incarnate, to whom the Holy Spirit bears unique and authoritative witness through the Holy Scriptures, which are received and obeyed as the word of God written. [The Confession of 1967, 9.27]

WE BELIEVE IN ONE LORD, JESUS CHRIST [Nicene Creed, 1.2]

It pleased God to come to us in Jesus Christ, Emmanuel, God with us. God did not simply show us a path to follow, but lived among us as the Way, the Truth, and the Life. Although we have done nothing to deserve the free gift of God, in Jesus Christ we receive new life, know the truth about God and ourselves, and are set upon God's way in the world. Jesus Christ was and is *the* path, for Jesus Christ was and is:

God from God, Light from Light, true God from true God, begotten, not made, of one Being with the Father [Nicene Creed, 1.2]

Jesus Christ came to us as one of us, sharing our joy and sorrow. He proclaimed God's love, healed the sick, and was a friend of sinners. He continues to reveal God's gracious love, he is among us now to make us whole, and he is still the friend of sinners. Jesus Christ was and is one with us in life; Jesus Christ was and is one with us in suffering and death. The Lord and Savior is Christ crucified, in whom God's weakness is stronger than human strength and God's foolishness is wiser than human wisdom.

He is the image of the invisible God, the firstborn of all creation ... For in him all the fulness of God was pleased to dwell, and through him to reconcile to himself all things, whether on earth or heaven, by making peace through the blood of his cross. [Colossians 1:15, 19-20]

The cross of Christ is at the heart of our faith, for it is through the Lord's death that we receive new life. The gospel of Christ crucified is a treasure that surpasses the limits of human language, and so the Bible displays a wealth of expression that leads us to thankful knowledge and grateful faith.

> God's reconciling act in Jesus Christ is a mystery which the Scriptures describe in various ways. It is called the sacrifice of a lamb, a shepherd's life given for his sheep, atonement by a priest; again it is ransom of a slave,

payment of debt, vicarious satisfaction of a legal penalty, and victory over the powers of evil. These are expressions of a truth which remains beyond the reach of all theory in the depths of God's love for humankind. They reveal the gravity, cost, and sure achievement of God's reconciling work. [The Confession of 1967, 9.09]

Jesus Christ is with us in life and death. But death is not the last word, for God has raised him from the dead and exalted him above all rule and authority and power and dominion. The risen Christ is the living Lord of the cosmos. "In Jesus Christ, God was reconciling the world to himself" [2 Cor. 5:19]. For the sake of the world, the Word became flesh, for the sake of the world Jesus Christ lived among us, was crucified and raised from the dead. For the sake of the world Christ ascended to heaven, and for the sake of the world Christ will come again. All of this is God's good pleasure set forth in Christ "as a plan for the fulness of time, to gather up all things in him, things in heaven and things on earth" (Eph. 1:10).

So we teach and believe that this Jesus Christ our Lord is the unique and eternal Savior of the human race, and thus of the whole world, in whom by faith are saved all who before the law, under the law, and under the Gospel were saved, and however many will be saved at the end of the world. [The Second Helvetic Confession, 5.077]

Jesus Christ is the only Savior and Lord, and all people everywhere are called to place their faith, hope, and love in him. No one is saved by virtue of inherent goodness or admirable living, for "by grace you have been saved through faith, and this is not your own doing; it is the gift of God" [Eph. 2:8]. No one is saved apart from God's gracious redemption in Jesus Christ. Yet we do not presume to limit the sovereign freedom of "God our Savior, who desires everyone to be saved and come to the knowledge of the truth" (1 Tim. 2:4). Thus, we neither restrict the grace of God to those who profess explicit faith in Christ nor assume that all people are saved regardless of faith. Grace, love, and communion belong to God, and are not ours to determine.

> Paul, after a beautiful development of his thought, in Rom. 10:17 at length comes to the conclusion, "So faith comes from hearing, and hearing from the Word of God by the preaching of Christ." At the same time we recognize that God can illuminate whom and when he will, even without the external ministry, for that is in his power. [Second Helvetic Confession, 5.006, 007]

WE BELIEVE IN THE HOLY SPIRIT, THE LORD, THE GIVER OF LIFE [Nicene Creed, 1.3]

The Holy Spirit unites us to Christ, draws redeemed people to a shared life of grateful praise, and shapes our lives in obedience to God's gracious law. The Spirit forms diverse people into the one body of Christ, giving a variety of gifts that enable us to upbuild the church and serve the world. The Holy Spirit is God's abiding presence among us, equipping us to proclaim the gospel, nurture each other in the fulness of communion, worship God, know and live the truth, cultivate justice, and exhibit God's new Way in the world.

> By the indwelling of the Holy Spirit all believers being vitally united to Christ, who is the Head, are thus united one to another in the Church, which is his body By him the Church will be preserved, increased, purified, and at last made perfect in the presence of God. [Westminster Confession of Faith, 6.054]

The power of the Holy Spirit leads the whole community of faith into holy and joyful living, enabling each of us to conform our lives more fully to Christ. Christians are called to live by the Spirit, forsaking works of the flesh and receiving the fruit of the Spirit.

I appeal to you therefore, brothers and sisters, by the mercies of God, to present your bodies as a living sacrifice, holy and acceptable to God, which is your spiritual worship. Do not be conformed to the world, but be transformed by the renewing of your minds, so that you may discern what is the will of God – what is good and acceptable and perfect. [Romans 12:1-2]

Because the church is founded and enlivened by the presence of Jesus Christ through the Holy Spirit, we can be confident that it is Christ who works through the imperfect and sinful fellowship of the church. Even in our brokenness we testify that we belong solely to Jesus Christ. In the power of the Holy Spirit, we proclaim Christ's love, in word and deed, to all the world.

The Christian Church is the congregation of the brethren in which Jesus Christ acts presently as the Lord in Word and sacrament through the Holy Spirit. As the Church of pardoned sinners, it has to testify in the midst of a sinful world, with its faith as with its obedience, with its message as with its order, that it is solely his property, and that it lives and wants to live solely from his comfort and from his direction in the expectation of his appearance. [Theological Declaration of Barmen, 8.17]

ONE LORD, ONE FAITH

Each time we gather at the baptismal font, we rejoice that God welcomes another person into fellowship with Christ. In one baptism, through the power of the Holy Spirit, we are united to Jesus Christ in his death and resurrection. In one baptism we are also united to our brothers and sisters in faith around the world. The waters of baptism do not belong to the Presbyterian church or to any particular church. They belong to God alone, and as we pass through these waters we are incorporated into the one body of Christ. It is our new life in Christ that we Presbyterians are called to celebrate, deepen, and share with the world. Let us join together, brothers and sisters, to proclaim the gospel of God's saving love in Jesus Christ.

> Beloved, build yourselves up on your most holy faith; pray in the Holy Spirit; keep yourselves in the love of God; look forward to the mercy of our Lord Jesus Christ that leads to eternal life. [Jude 20-21]

Section VI. Ministries Division Committees:

(a.) Worldwide Ministries Division (WMD)

1. Purpose

The purpose of the Worldwide Ministries Division is to

- a. share the transforming power of the gospel of Jesus Christ with all people;
- b. carry out mission in Jesus Christ's way by being committed to the whole church, the whole gospel, and the whole inhabited earth.
- 2. Committee Membership
 - 1. Committee membership shall include voting members of the General Assembly Council, one ecumenical advisory member, and the Stated Clerk of the General Assembly as a corresponding member with voice and without vote. One of the voting members shall serve as chair. (For elected member liaisons, see VII.D.9.)
 - 2. Each member shall serve on one of the following subcommittees: Ecumenical Partnership, Global Service and Witness, People in Mutual Mission.
 - c. Each member shall also seve on one of the following geographical area groupings: a. Africa, b. Asia, c. Europe/Middle East, d. Latin-America.
 - 4. The number of members in each subcommittee or geographical area grouping shall be determined by the Ministries Division as appropriate to the work assignment.
- 3. Responsibilities

Five central commitments around which the PC(USA) shapes its global and ecumenical mission are:

1. Demonstrating good news to the poor;

- 2. Supporting the new opportunities for churches in the socialist countries and former socialist countries;
- 3. Sharing the good news with those outside the church;
- 4. Engaging in reconciliation and witness with people of other faiths;
- 5. Seeing the United States of America as a mission field.

4. Strategies for Carrying Out Mission

- a. Affirming our partnership with the church in each place as the primary agent of mission and evangelism.
- b. Renewing our ecumenical commitment including the selection of ecumenical representatives to the General Assembly Council.
- c. Engaging in new patterns of sharing people and resources in mission.
- d. Enabling Presbyterians to participate in Presbyterian worldwide mission.

5. Program Areas

- a. Ecumenical Partnership
 - (1) Goal: To enable the PC(USA) to share itself, its faith, and its resources with church partners, ecumenical bodies, and interfaith organizations in humility and love so that all of us shall be mutually encouraged and enriched by the gospel of God's kingdom.
 - (2) Related Programs: Ecumenical Coordination and Interfaith Relations; Partnership Coordination with Area Coordinators; Presbytery/Synod Partnerships.
- b. Global Service and Witness
 - (1) Goal: To share the love of Christ through witness and sharing of resources entrusted to the PC(USA) with partners in the United States of America and throughout the world in order to help alleviate human suffering; strengthen communities; support the empowerment of persons through education and development; and find wholeness and justice in

fuller measure for themselves and others.

The president and executive vice president/chief financial officer (the "treasurer") shall be elected by the board of directors with the concurrence of the General Assembly Council for a term of four years subject to confirmation by the General Assembly and shall be eligible for reelection. Other officers of the corporation shall be elected annually.

Background

This change reflects an amendment to the PC(USA), A Corporation's by-laws approved by the Board of Directors at the meeting of February 19, 2001.

(e.) Section VII. Election Procedures (found on page 33 of the current *Manual of Operations:*

Add a new F. following E. Absences, and re-letter the present F. as G. as follows:

F. Resignation

A member of a General Assembly entity who finds it necessary to resign shall send his or her resignation to the Stated Clerk of the General Assembly, who shall notify the entity and the nomination committee or other body that originated the person's nomination or election. When any member of an entity of the General Assembly (council, commission, unit, division, committee, task force, or any other body) shall resign, or becomes unable to serve because of chronic or permanent physical or mental illness or disability, the Stated Clerk of the General Assembly shall declare the position vacant. (Standing Rules of the General Assembly, E.1.e.)

4.12 TERMS OF SERVICE

- 4.12a Mission Co-Workers will be appointed to a term of service of three, four, or five years. The length of term will be set in advance, based on the needs of the partner church, and the most appropriate schedule for interpretation assignment. A term of service of five years (60 months) will only be approved after the mission co-worker, the partner church and the matrix staff have consulted and agreed that a one year absence from the place of service is feasible and appropriate.
- 4.12b Review for reappointment or reassignment will follow the procedure outlined in Section 4.13.
- 4.12c Duration of Interpretation Assignment
 - a. The length of interpretation assignment for each term of service will be calculated upon a proportion of the period served.
 - b. As interpretation assignment is a significant and vital portion of the term served, mission Co-Workers are expected to spend time on the field in planning and preparation for this period of service. Mission Co-Workers must communicate to the Coordinator for Mission Co-Workers a plan for Interpretation Assignment no less than six (6) months in advance of departure from the place of service.
 - c. Term of service of three years (36 months) includes a period of Interpretation Assignment at the conclusion of the term of no less than three (3) months. An additional three (3) months may be added with a reappointment.

d. Term of service of four years (48 months) includes a period of
 Interpretation Assignment of no less than four (4) months. An additional
 four months may be added with a reappointment.

Interpretation Assignment may be taken in two (2) segments of two to three (2-3) month periods but should not include annual vacation. In this case the Mission Co-Worker Office pays for two (2) round trips per term.

- e. Term of service of five years (60 months) includes a period of Interpretation Assignment of no less than one year (12 months). In this case the Mission Co-Worker Office will pay for up to two round trips per term to allow for a mid-term break of at least two (2) months.
- f. Terms of service or Interpretation Assignment which vary from the policy outlined above will be considered if proposed in writing to the Coordinator for Mission Co-Workers no less than six (6) months in advance of departure from the place of service.

CRITERIA FOR ANNUAL INSURANCE COMPANY SURVEY

The selection of insurance companies to be profiled will be based upon the market share of the Presbyterian Church (U.S.A.) churches written by each company. Companies selected for profile must write a minimum of 10% of the Presbyterian Church (U.S.A.) churches. The 10% criteria will be established by baseline data from a survey conducted in 1999 and approximately every 3 years thereafter. The survey will be sent only to Presbyterian Church (U.S.A.) churches. The companies selected will be asked to verify the 10% market share.

Each company will provide its annual report to the Risk Management Office by February 1 of each year with the following information:

- Number of Presbyterian Church (U.S.A.) churches insured
- Number of Presbyterian churches cancelled
- Number of Presbyterian churches non-renewed or declined and for what reasons.
- Loss ratio for the Presbyterian churches within the company
- Any unusual market forecasts or emerging issues for churches

The insurance company will also provide the Risk Management Office with a contact representative at each company.

Failure to provide this information annually will result in the removal of the company from the profile process.

DRAFT LETTER TO CHURCHES AND MIDDLE GOVERNING BODIES TO BE SENT AFTER GAC ACTION

Dear Sisters and Brothers in Christ,

More than twenty years ago the General Assembly, in response to urgent needs in various parts of the country, began a relationship with the GuideOne Insurance Company (then Preferred Risk Mutual) and an agency system overseen by American Coverage Administrators. This long and successful relationship has provided affordable and comprehensive insurance coverage to Presbyterian churches and middle governing bodies.

Over the past few months, a task group of the General Assembly Council has reviewed this relationship as well as the opportunities churches now have to cover their insurance needs. The insurance circumstances for churches and the insurance industry have changed. The marketplace now has at least three major providers of insurance to Presbyterian churches, all of which are able to provide the minimum insurance standards recommended to congregations.

In light of our analysis, we will end our **exclusive** relationship with GuideOne and American Coverage Administrators on December 31, 2002. After that date, we will make available to our churches comparative information on all insurance carriers that insure at least 10% of Presbyterian Church (U.S.A.) churches and meet other basic requirements.

Please know we are trying a **new pattern** for assuring that the best value insurance coverage is available to all churches and church activities in all parts of the country. This pattern will be evaluated in 2004 to be sure that it continues to serve our needs. GuideOne and American Coverage Administrators will be an important part of this new pattern and we are assured they will continue to provide innovative ways to serve the insurance needs of the denomination.
