The Presbyterian Church (U.S.A.) has endorsed the boycott of Wendy's, launched by the farmworker-led Coalition of Immokalee Workers (CIW). Only the second one in their long campaign, the boycott was called in response to the fast food company's decision to reject the Fair Food Program – a worker-designed, proven human rights program that is preventing violence, wage theft, sexual assault, and slavery in the Florida tomato industry and beyond.

Wendy's stands alone in its refusal to join the Fair Food Program. Instead, it has moved much of its tomato purchasing from Florida to a supplier in Mexico where slavery was uncovered in 2013.

Presbyterians are joining with thousands farmworkers, students, and people of faith around the country in boycotting Wendy's and pressuring them to uphold human rights and do right by farmworkers in their supply chain.

The PC(USA) and its predecessor bodies have supported fair wages for farmworkers, the right for farmworkers to bargain collectively, and a variety of boycotts over the last century as a nonviolent way to express our Christian values and urge social change. Key theological statements by the General Assembly, such as "God's Work in Our Hands" (2005) and "Christian Faith and Economic Justice" (1984), undergird the PC(USA) Campaign for Fair Food's ongoing work.
